Eagle Valley is owned by the City of Carson City and operated by TD's Golf at Eagle Valley, LLC. Wolf Run Golf Club is owned and operated by Duncan Burgess, LLC. LakeRidge Golf Course is owned and operated by Duncan Golf at Lake Ridge, LLC. Each facility and its owner are referred to in this Agreement as a "Club".

The Member hereby agrees to pay the Club, the membership fee. The Member agrees that annual fees may be increased or decreased by the Club, in the Club's sole discretion, and understands that such fees will probably increase over time. The membership fee is a **nonrefundable**, **one-time payment** and shall be paid by the Member and delivered to the Club within five (5) business days of execution of this Agreement by the Club. In the event that any amounts owed to the Club are not paid on a timely basis, the Member is liable for a late payment fee or the membership may be recalled.

A Member is not liable for assessments arising from capital improvements, renovations or repairs.

Membership is contingent upon approval by the Club and execution hereof, which approval shall be at it's sole discretion. Upon signing the Agreement, the undersigned authorizes the disclosure and release of information to the Club for investigating the Member's qualifications for membership, including credit history. The Member holds the Club harmless from any and all such



acts. The Club retains the right in its sole discretion to disapprove the Member's application for membership and decline to sign this Agreement.

The membership fee is paid in consideration for the Member's right to play the golf course (s) in accordance with the current memberships being offered.

This Agreement supersedes and renders void any prior Membership Agreement relating to the same Club facility previously in effect.
